PROGRAM IMPROVEMENT and ASSESSMENT COMMITTEE (PIAC)

The Program Improvement and Assessment Committee (PIAC) provides a forum for collaborative and cross-disciplinary work on unit and program assessments. The PIAC meets a minimum of five times during the academic school year and is comprised of program coordinators from each initial and advanced program accountable to the Council for the Accreditation of Educator Preparation (CAEP). Sub-committees monitor the work of the whole to ensure the unit is addressing the CAEP standards.
